## Location of the Institute:

IIIT Tiruchirappalli is located about 20 kms from Tiruchirappalli Junction/Central Bus stand on the Tiruchirappalli-Madurai Highway. Tiruchirappalli is also well-connected to the other cities of Tamil Nadu, southern Karnataka and Kerala through Govt./Private buses. One can get buses from Tiruchirappalli to almost any part of the state, due to its geographical location in the center of Tamil Nadu. The Central bus station runs long distance services to major cities of the State and South India such as Chennai, Madurai, Coimbatore, Bangalore, Erode, Thiruvananthapuram and Tirupathi.

## How to reach IIIT Trichy?

Tiruchirappalli is an important junction on the Southern Railway. It connects Chennai, Thanjavur, Madurai, Tirupati, Rameswaram, Bengaluru, Coimbatore, Kolkata, Jammu, New Delhi, Cochin and Mangalore. It has an international airport, and is connected with Chennai, Dubai, Kuala Lumpur, Singapore and Colombo. Frequent bus service is available from Tiruchirappalli central bus stand, every 15 minutes. Get on the Viralmalai bus Route: Trichy -Edamalaipatti puthur - Panjappur- Nagamangalam - Kunnathur - Alundur – Sethurappatti. By car it takes approximately 30 minutes from Tiruchirappalli railway station/airport/bus stand.
