**III. Terms & Conditions for Diploma / Graduate Apprentices:**

**i. Minimum Educational Qualifications:**

- Full Time graduate degree granted by a recognized university / Institutions in relevant discipline.

- Diploma in Engineering / Technology in full time granted by a State Council or Board of Technical Education Established by a State Government / University / Institutions in relevant discipline.

## **ii. Other Eligibility Requirements:**

1. Graduate / Technician candidates who have passed the qualifying exam in 2021/2022/2023/2024/2025 are only eligible.
2. Candidates who have registered themselves in the Apprenticeship Portal for Apprenticeship and who fulfill the eligibility criteria as indicated above will be considered for appearing in the walk-in-interview.
3. Candidates should not have undergone or presently undergoing Apprenticeship Training in IIIT or elsewhere.
4. Candidates should not have experience of one year or more in any job.
5. Sandwich diplomas, private diploma, part time/Distance/short term/certificate courses etc. are not acceptable.

## **iii. Age:**

**Technician/Diploma:** Minimum 18 years and maximum 24 years for Technician/Diploma Apprentices as on date on Interview.

**Graduate/Degree:** Minimum 21 years and maximum 26 years for Graduate/Degree Apprentices as on date of interview.

**Relaxation:** (Relaxation by 5 years for SC/ST, 3 years for OBC, for the posts reserved for them). Candidates belonging to PWD Categories shall be given age relaxation up to 10 years (up to 15 years for SC/ST and up to 13 years for OBC (Non-Creamy Layer) Candidates).

## **iv. Reservation:**

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government Standard format, failing which their claim for reservation will be considered as 'General' category only. BC candidates claiming OBC (Non creamy layer) category should submit OBC (NCL) certificate as per the approved (OBC-NCL) format from the certificate issuing authority.

## **v. Apprenticeship Registration:**

- Category Certificate [for SC/ST/OBC (Non-Creamy Layer)/EWS candidates as applicable] in the prescribed format issued by the Competent Authority as prescribed by Government of India.
- Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above at the time of walk-in-interview, their candidature will not be considered.
- Successful apprenticeship trainees will be awarded National Apprenticeship Certificate by National Council for Vocational Training (NCVT)/BOAT.
- Upon completion of the apprenticeship period IIIT shall have NO obligation to offer employment to such apprentices nor can an Apprentice claim right for employment on the grounds of completion of Apprenticeship.

4. If number of candidates are more, the selection Committee shall adopt its own criteria and shortlist the candidates for walk-in-interview in proportionate to the available vacancies.
